

# BUDGET RESOLUTION 2018-179

## A RESOLUTION TO ADOPT A FINAL BUDGET FOR THE CITY OF OCALA FOR FISCAL YEAR 2018-2019 IN THE AMOUNT OF \$786,258,515

**WHEREAS**, the City Council reviewed the proposed budget during a public workshop on August 16, 2018; and

**WHEREAS**, in accordance to Florida Statutes, Section 200.065, the Property Appraiser's Office mailed proposed tax bills on August 16, 2018 and a public hearing was held on September 5, 2018 to adopt the tentative millage rate and budget for the City of Ocala; and

**WHEREAS**, the required notice of tax increase and budget advertisements were published on September 8, 2018 and a public hearing to adopt the final millage rate and budget was held on September 12, 2018; and

**WHEREAS**, this resolution includes the budgets for the Redevelopment Subarea Funds that were adopted by the Community Redevelopment Agency Advisory Board and the Downtown Development Fund previously adopted by City Council.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OCALA, FLORIDA**, duly assembled that the annual budget of \$786,258,515 for the City of Ocala for the period beginning October 1, 2018 through September 30, 2019, is hereby adopted as follows:
